Code Enforcement Report: Mary Kendrick told the council she was pleased with the progress. She went on to say that after speaking to the city attorney, those who refused their certified letter will be receiving a citation to appear in court July 2nd, at 4pm.

Public Forum: 5 minutes to speak per person.

- Karen Walker: Happy about the city clean-up efforts.
- Michelle Johnson: Happy to be here in Sylvia and everyone has been helpful and nice.
- Danial Gosser: Willing to assist the city superintendent when needed and is interested in being considered for a part-time position in the future.
- Andi McMillin: Read a letter thanking the council for working towards enforcing ordinances.

Old Business:

- Railroad Tie Removal: Tabled
- Sewer Rates: Discussion was had regarding sewer issues and how the city is losing money due to the increase in cost to maintain the system as well as the current sewer rate being very low without an increase in over five years. The city's current rate of \$16.50 is well below the national average as well as far below neighboring city's/towns.

Motion to increase the city's sewer rate by \$6.50 beginning Aug. 1st, making the billing total \$23, and revisit the issue Jan. 1st, 2026, for another possible increase by: K. Keesling

Aug. 1st billing date was chosen to allow for notification and awareness through the minutes as well as the community newsletter.

- Trash Rates: Will remain unchanged.
- Water Project update: The city was notified that the land where the new water wells will be located will be graciously donated to the city by the Karen Davidson family. Schwab Eaton will conduct a survey of the ground and city personnel will arrange to meet with Davidson family at an agreed upon tile company for the transfer of ownership.

New business:

- A letter of recommendation from The Nazarene Church was requested for a grant they will be applying for. The request was granted and will be written by the clerk.
- Black Hills quote for gas system: The city received a quote of \$30,780 to install a new ground bed. This includes boring for each anode, installation of carbon anodes, vent/water piping, trenching, cable installation, wiring to rectifier, and all back fill with clean-up.
The city will be requesting a quote for just new anodes.
- City employee bond amount: research and revisit.
- Tornado Siren discussion: With the help of Ethan Ketchum the city will contact Reno County Emergency Management to schedule a meeting to establish protocol.
- Utility Ordinance Discussion: The ordinance will remain as written at this time.
- PJ Carlson House: Trust information and details will be looked into.
- Sunflower Building roof: The roof is currently leaking due to the amount of rain we've received. Ray Roofing has been contacted for an estimate. Others to possibly follow.
